N.B. :

- I. *The registered teacher need to inform the University soon after change of the work place for correction in the Registrar. Once the teacher is transferred to other College / University outside F.M. University jurisdiction and / or superannuated from service they shall cease to be a registered teacher of the University. They need to intimate the same for record.*
- II. *As per Statute 109 of Odisha Universities First Statute, 1990, "If a person who has paid the prescribed fee for the registration of his name as a Registered Graduate or Registered University Post Graduate Teacher or Registered College Teacher or Registered University Non-teaching employee ceases to be qualified for the retention of his name in that particular register, but becomes qualified for the entry of his name in any one of the other registers, his name shall be struck off from the former register and shall be entered in the later register on application to the Registrar "*
