The term of the Chairperson and members shall be for a period of two years and that of Special Invitee is one year.

The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.

A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson, Students' Grievance Redressal Committee.

The SGRC shall send its reports with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, preferable within a period of 15 working days from the date of receipt of the complaint.

Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson of F.M. University, within a period of fifteen days from the date of receipt of the decision.
