No. 31369—1. HE.-U-67/99-HE.—In exercise of the powers conferred by sub-sections (1) and (2) of Section 32 of the Orissa Universities Act, 1989 (Orissa Act 5 of 1989), the State Government do hereby alter the territorial jurisdiction of the North Orissa University by exclusion of the Revenue Districts of Balasore and Bhadrak and establish a new University called as the "Fakir Mohan University" having jurisdiction over the Revenue Districts of Balasore and Bhadrak with effect from the 11th July 1999.
