OFFICE ORDER

The following guidelines must be followed scrupulously while submitting the Examiners list by the Ph.D. Supervisor with an immediate effect:

1. The concerned Supervisor must submit the list of eight (08) Examiners who are experts in the respective field of research and not in employment of this University. Such examiners should be academicians with good record of scholarly publications in the field.
2. Out of the eight (08) examiners, not more than one (01) from a University and not more than two examiners from a state can be proposed as Examiners.
3. Generally, only Professors can be empaneled as examiners. However, only in special situation, an extraordinary expert may be in the rank of Associate Professor (with at least two years of experience) can be proposed as the examiner.
4. Necessarily, all the examiners must be from outside the state of Odisha, and in case of the subject Odia, at least two (02) examiners out of eight (08) must be from outside of the state of Odisha.
5. The details of examiners including designation, affiliation, experience, complete postal address with PIN code, email ID, and mobile number with alternate mobile number must be submitted in printed hard copy with a cover letter by the Supervisor. In case the Supervisor/Co-supervisor are not the employee of Fakir Mohan University, then the details of afore mentioned information of Supervisor/Co-supervisor must be submitted in a separate page along with the examiners list.
6. The list of examiners must be submitted six months prior to the thesis submission.
